1.0 SUBMISSION OF PROPOSALS

A. All proposals shall be on the form provided with these instructions. The Contractor shall deliver its Proposal with all required documentation via email to Brooke Breiner at bbreiner@hbmarchitects.com and Tiffany Poje at tpoje@hbmarchitects.com or deliver one hard copy to the office of HBM Architects, 1382 West 9th Street, Suite 300, Cleveland, OH 44113 **on or before March 7, 2024 at 3:00 p.m. CT**. B. The Owner is exempt from all sales, excise and transportation taxes. Any taxes other than these, which are applicable, are to be paid by each respective Contractor. The owner will furnish Tax Exemption Certificates to the selected contractor(s) upon request.

2.0 EXAMINATION OF DRAWINGS, SPECIFICATIONS AND SITE OF WORK

A. Before submitting a Proposal, each Contractor shall carefully examine all Drawings, read the Specifications, Addenda, and all other Contract Documents, and visit the site of the Work. Each Vendor shall fully inform himself prior to bidding as to all existing conditions and limitations under which the Work is to be performed and he shall include in his Proposal a sum to cover all costs of all items necessary to perform the Work as set forth in the Contract Documents. No allowance will be made because of lack of such examination or knowledge.

3.0 INTERPRETATION OF CONTRACT DOCUMENTS

A. If any Vendor is in doubt as to the true meaning of any part of the Contract Documents or finds discrepancies in or omissions from any part of the Contract Documents, he may submit to the Architect a written request for interpretation thereof not later than four days before proposals will be opened. The person submitting the request shall be responsible for its prompt delivery. B. Any interpretation or correction of the Contract Documents will be made only by Addendum and will be emailed to each Vendor. The Owner will not be responsible for any other explanations or interpretations of the Contract Documents.

C. Discrepancies: In case of discrepancies between plans and specifications, the higher quantity and quality shall prevail.

4.0 STANDARDS - SUBSTITUTIONS

A. Proposals must be based on the products specified.

B. Refer to Pricing Form for Conditions of Substitution requirements.

5.0 WITHDRAWAL OF PROPOSALS

- A. No Vendor shall modify, withdraw or cancel his proposal or any part thereof within sixty (60) days after the time designated for the submittal date.

6.0 AWARD OR REJECTION OF PROPOSALS

- A. The Owner reserves the right to accept or reject any or all proposals, accept components of proposals, and to waive any informalities or irregularities.
- B. Acceptance of the proposal of any vendor shall not be binding upon the Owner until a written agreement stipulating all provisions of the work to be performed has been executed by both the Owner and the Vendor.
- C. The Owner reserves the right to selectively award contract or multiple contracts based on individual or groups of manufacturers.

7.0 EXECUTION OF AGREEMENT

- A. The Owner will issue a purchase order for all furniture.

8.0 SCHEDULE

***NOTE: Dealer shall notify designer if finish selections result in a delay of installation. Reselections may be considered in order to maintain schedule.**

- A. FURNITURE INSTALLATION: The Agreement will stipulate that the Work, **shall begin furniture installation the week of July 15, 2024** and substantially completed no later than 5 business days after established installation date based on current construction schedule. Vendor is responsible for coordinating installation dates with H.W. Houston Construction, Steve Vasquez @ Office 719.377.1915.
- B. The date of substantial completion is the date certified by the Owner's Representative when construction is sufficiently complete, in accordance with the contract documents, that the Owner may occupy or use the work for the use for which it is intended.
- C. Should the Vendor fail to substantially complete the work by the substantial completion date, he shall be deemed to be in default of this contract and the Owner shall be at liberty to immediately thereafter have the work completed and to deduct from monies owed the Vendor all costs incurred in the completion of the work.

1.1 DESCRIPTION

- A. Work Included:

 2. All fabrics specified are part of this contract and supplied by Vendor.
 3. Vendor must include and coordinate all furniture assembly, delivery(ies) and incidental items required for a complete installation.

1.2 QUALITY ASSURANCE:

- A. Manufacturer's and Installer's Qualifications
1. The manufacturer and installer of Work of this Section shall have 5 years minimum proven experience in such Work and shall have satisfactorily completed 3 jobs of similar size and type within the last 5 years.
 2. All furniture must comply with CA 117.
 3. ***All fabric must comply with Prop 65.***

1.3 SUBMITTALS:

- A. Submittals
1. Installer's Certification of Qualifications.
 2. Itemized List: Itemized list of all furniture showing complete description of each item of furniture including model numbers.
 3. Complete Manufacturer's literature, technical data and installation instructions for each type of furniture.
 4. Samples of all materials for verification purposes: Submit samples of each type, color, finish, pattern and texture required, showing full range of variations.
 5. Submit furniture plans verifying locations of all items.
 6. Submit all warranties
- B. All submittals must be received by the Architect with-in 10 business days after execution of purchase order from Owner, and before any materials of this Section are delivered to the job site.

1.4 SUBSTITUTIONS

- A. Substitutions may be submitted for products specified.
1. The Owner reserves the right to determine what is equal and acceptable in its sole discretion. Any proposed substitution(s) must meet or exceed the specifications set forth in this section.
 2. Refer to Pricing Form for Conditions of Substitution requirements.

1.5 FIELD MEASUREMENTS

- A. Assume responsibility to make field measurements to assure furniture can be moved to installation location.

1.6 PRODUCT HANDLING

- A. Protection: Use all means necessary to protect the work of this Section before, during and after installation and to protect the installed work and materials of all other trades.
- B. Replacement:
In the event of damage, immediately make all repairs and replacement necessary subject to the approval of the Architect and at no additional expense to the Owner. In the event that rejected furniture cannot be replaced before occupancy and use of the building, the rejected items shall be allowed to remain in use until replaced at no expense to the owner.

1.7 STORAGE OF FURNITURE

- A. No additional costs shall be approved for storing furnishings in order to meet the installation date set by the owner's representative.

1.8 WARRANTY

- A. Dealer shall provide a minimum one year warranty along with any extended manufacturer's warranties.
- B. Manufacturer Warranties: Include all manufacturer warranties with submittals for each manufacturer and / or item.

1.9 DELIVERIES

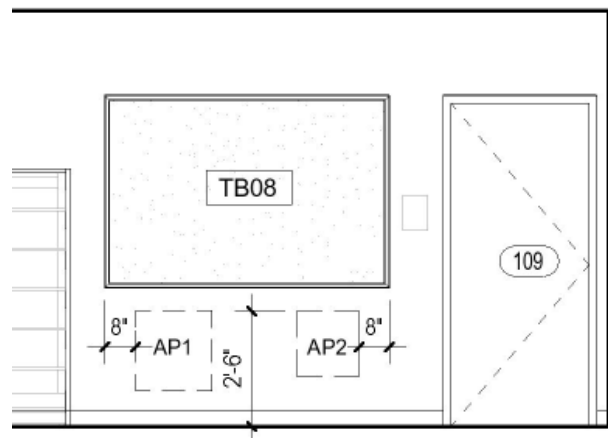
- A. No direct shipment or "drop shipment" of goods will be received by the Owner. All items shall be delivered and installed by vendor. Vendor/Installer can arrange to meet the truck and unload all furniture.
- B. All cartons and trash incidental to the furnishings shall be removed from the job site by the Vendor each day. No debris shall accumulate.
- C. All furnishings shall be arranged in their final position as soon as it is agreed that the areas are ready for receipt of furniture.
- D. Vendor is responsible for plugging in all powered furniture into appropriate receptacles and complete wire management installation to conceal associated cords and wires.
- E. Before installation, the Owner and Vendor shall make inspection of the route from the staging area to the final location of the furniture, itemizing all areas unfinished or damaged and still in need of Work by other Contractors.
- F. After installation of furniture a final inspection shall be made by the Owner and Vendor, following receipt in writing of notification that the installation is completed. If inspection reveals any damage due to the installation of the furniture, the damage shall be repaired by the vendor at no expense to the owner.
