

**MEMORANDUM OF UNDERSTANDING
REGARDING
THE PUEBLO CITY-COUNTY LIBRARY DISTRICT COLLABORATION WITH
PUEBLO ~~CITY~~SCHOOLS DISTRICT NO. 60**

This Memorandum of Understanding (this “Agreement”) is made and entered into this **DATE TBD** between ~~The~~ Pueblo ~~City~~ Schools District No. 60 (known as “PCSD60”) located at 315 W. 11th St., Pueblo, Colorado 81003 and Pueblo City-County Library District (known as “PCCLD”) located at 100 E. Abriendo Avenue, Pueblo, Colorado 81004.

Background

WHEREAS, ~~In the~~ Spring ~~of~~ 2015 ~~the Pueblo City County Library District~~ PCCLD was contacted by the White House to participate in an initiative called “ConnectED.” The goal of the ConnectED initiative calls upon library directors to work with their school leaders, school librarians, and city officials to provide wider access to the learning resources and books of America’s libraries; and

WHEREAS, ~~S~~shortly after President Obama announced his ConnectED ~~i~~Initiative ~~last in~~ April, 2015, PCCLD began a discussion with city and school officials exploring a method and commitment to this initiative; and

WHEREAS, ~~M~~more than 60 cities, are participating in the ConnectED Library Challenge. ~~In and, in~~ addition to ~~Pueblo City County Library District~~ PCCLD and the local school districts, this initiative includes partnerships with the Institute of Museum and Library Services (IMLS), the American Library Association (ALA), the Urban Libraries Council (ULC), and The White House; and

WHEREAS, ~~T~~he purpose of the ConnectED initiative is to develop an infrastructure that will ~~allow give Pueblo County~~ students ~~in Pueblo County~~ access to and use of ~~the Library~~ PCCLD’s physical and digital materials freely; ~~and leverage the collaboration of the Library~~ PCCLD and PCSD60 ~~will leverage our collaboration~~ for innovative and cost effective ways to better utilize ~~the library~~ PCCLD’s resources to serve PCSD60 students, ~~their~~ families, and staff; and

History of Relationship

WHEREAS, PCCLD and the PCSD60 have had an ongoing relationship in ~~the~~ their mutual effort to improve the lives of the citizens of Pueblo. ~~In addition by providing~~ to access to books, computers, and online resources; ~~PCCLD has provided~~ providing opportunities for Early Literacy, STEM exploration, seasonal reading incentives, visiting authors; ~~and much many~~ more educational opportunities, both in-school outreach and during out-~~of-~~school activities; and

WHEREAS, ~~B~~both organizations have aligned around a focus on literacy and are committed to creating a community of readers; ~~;~~ empowering individuals with free access to information; ~~;~~ building a welcoming place where reading, learning, and imagination thrive; ~~;~~ maximizing academic achievement; ~~;~~ and preparing every child to lead a rich and productive life.

NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS AGREEMENT, THE PARTIES AGREE AS FOLLOWS:

1. Services Provided without Cost: Both PCSD60 and PCCLD agree that the services to be provided by PCCLD shall be provided at no cost to PCSD60.
2. Term: Subject to earlier termination as provide herein, ~~T~~the term of this Agreement shall commence as of ~~is from~~ the date first written above and continue through June 30, 2017.
3. PDDL's Obligations: In connection with this Agreement, ~~the Library~~PCCLD agrees to the following:
 - A. ~~Pueblo City County Library District will s~~Streamline student access to databases and materials by integrating PCSD60 Student ID numbers into PCCLD accounts through the ConnectED initiative. This will, allowing allow every student in ~~Pueblo City Schools District 60~~PCSD60 instant access to ~~Library~~PCCLD databases and materials, ~~to enhance the technology and material access and available to students.~~ Implementation will include training for students and staff ~~of the Library's~~ in how to efficiently and effectively access PCCLD's educational resources.
 - B. Work collaboratively with PCSD60 to further ~~deepen~~ the partnership between ~~the Library~~PCCLD and PCSD60 and their common goals.
 - C. Provide PCSD60 with data about student participation in annual summer reading program, including student name, grade, and school.
 - D. Establish a data field into ~~the Library~~PCCLD's integrated library system ("System") and identifying identify all cards issued to the PCSD60 students through the ConnectED Initiative. The PCSD60 Student ID Number will be stored in the System and used as the User ID and, the ~~library~~PCCLD card number.
 - E. Work jointly with PCSD60 to develop a handout/letter describing the policy/goals of the ConnectED ~~i~~Initiative.

- F. Work jointly with PCSD60 to develop and disseminate external media coverage.
 - G. Provide ongoing training related to use of library resources, including, but not limited to, online resources.
 - H. PCCLD will continue to develop and provide appropriate collections to ~~assist with the overall~~promote reading ~~for~~by children and adults in the whole community.
4. PCSD60's Obligations: In connection with this Agreement, ~~the~~PCSD60 agrees to the following:
- A. ~~Pueblo City Schools District 60 will s~~Support implementation of the ConnectED ~~i~~Initiative by providing to ~~Pueblo City County Library District~~PCCLD: Student ID Number, first and last name, birthdate, address, phone number, email address, and parent/guardian of each student enrolled in 2016. The database will be updated bi-annually beginning in July 2016 as new students enroll in the district. For the 2016-2017 school year data shall be provided during October 2016 and February 2017. Beginning October 2016, school year data shall be provided every October and February of each school year.
 - B. Provide an option at registration or during record updates for the parent/guardian to opt-out of this program, and provide that information to PCCLD so the records may be updated.
 - C. In collaboration with PCCLD staff, help to facilitate the introduction of professional development opportunities for PCSD60 teachers on an annual basis, surrounding the ConnectED initiative and other PCCLD projects.
 - D. Distribute ~~policies/goals/awareness~~information about the ConnectED Initiative to all students and guardians of PCSD60.
 - E. Work jointly with PCCLD to develop a handout/letter describing the policy/goals of the card initiative.
 - F. Work jointly with PCCLD to develop and disseminate external media coverage.
5. Data Privacy and Security: The parties agree that all student data or student personally identifiable information, as defined herein-, provided by PCSD60 is considered confidential under this Agreement as well as under the Family Educational Rights and Privacy Act (FERPA), and any other federal or state regulations pertaining to students'

education records. “Student Personally Identifiable Information” (hereinafter, PII) means information that, alone or in combination, personally identifies an individual student or the student’s parent or family, and that is collected, maintained, generated, or inferred by PCS60 or PCCLD, including, but not limited to a student’s name, the name of the student’s parent or other family member, the address of the student or a student’s family, a personal identifier such as a student’s social security number, student number or biometric record, and other indirect student identifiers such as a student’s date of birth, place of birth, or mother’s maiden name. To the extent that PCCLD has access to any ~~personally identifiable information~~ PII from students’ education records or otherwise, PCCLD agrees that it shall not use such information except for the legitimate educational purpose of providing services pursuant to this Agreement and that it shall not re-disclose this information to any other party for any other reason. PCCLD’s staff agrees to comply with all applicable federal and state regulations governing the student records, including FERPA. For purposes of this Agreement, it is acknowledged that PSD60 shall at all times have direct control over PCCLD with respect to PCCLD’s use and maintenance of PII and PCCLD will, at PCS60’s written request or upon termination or expiration of this Agreement, promptly return to PCS60 all PII or securely dispose of all PII.

5-6. Confidentiality of PCCLD Users: The parties agree that PCCLD supports and complies with the Colorado Library User Records Privacy ~~ACT~~ Act (C.R.S. ~~1972, § 24--90-119, 2015~~) with respect to the confidentiality of library records. All library records relating to a customer’s use of PCCLD and its resources are confidential.

6-7. Confidentiality Compliance: PCCLD’s staff will sign statement in which they agree to keep confidential all ~~PCSD60~~ student record information.

7-8. Project Coordinator. R. Dalton Sprouse, Director of Communication, is designated as the Project Coordinator for ~~the PCSD60~~. The project coordinator shall be the ~~PCSD60’s~~ representative in connection with the performance of PCCLD under this Agreement.

8-9. PCCLD Supervisor. Jon Walker, PCCLD Executive Director is the designated as the Project Coordinator and Supervisor for ~~the Pueblo City County Library District~~ PCCLD. The PCCLD Supervisor is fully authorized to act on behalf of PCCLD in connection with this Agreement.

9-10. Indemnity. To the extent permitted by law but without waiving any of the protections provided by the Colorado Governmental Immunity Act, PCCLD each party shall indemnify, protect, defend and hold ~~PCSD60~~ the other, its members, officers, directors and employees harmless from and against any and all losses in connection with injury (including death) or damage to any person, property, or business sustained

resulting from negligence ~~or willful misconduct~~ of ~~PCCLD~~, its agents, contractors, employees and licensees. ~~PCSD60BE shall indemnify, protect, defend and hold PCCLD, its members, officers, directors and employees harmless from and against any and all losses in connection with injury (including death) or damage to any person, property, or business sustained resulting from negligence or willful misconduct of PCSD60BE, its agents, contractors, employees and licensees.~~

~~10.11.~~ Expenses. Any expenses related to the provision of services incurred by PCCLD shall be the sole responsibility of PCCLD incurring such costs.

~~11.12.~~ Termination for Convenience. In addition to all the other rights which ~~PCSD60~~ or PCCLD may have to cancel this Agreement, each shall have the further right, without assigning any reason ~~thereforetherefor~~, to terminate any work under this Agreement, in whole or in part, at any time at its complete discretion by providing thirty (30) days notice in writing to the other party at the address identified below.

~~12.13.~~ No Partnership. The provisions of this Agreement are not intended to create, and shall not be interpreted to create a joint venture, a partnership or any similar relationship between the parties. No officer, manager, director, employee, agent, affiliate or other person associated with one party shall be deemed to be an officer, manager, director, employee, agent, contractor subcontractor of the other party by reason of this agreement.
