

**PUEBLO CITY-COUNTY LIBRARY DISTRICT  
RESOLUTION TO ADOPT ANNUAL BUDGET**

A resolution summarizing expenditures and revenues for each fund and adopting an annual budget for the Pueblo City-County Library District for the calendar year beginning on the first day of January, 2024 and ending on the last day of December, 2024.

**WHEREAS**, the Board of Trustees of the Pueblo City-County Library District has appointed the Executive Director of the Pueblo City-County Library District to prepare and submit a proposed budget to this governing body at the proper time, and;

**WHEREAS**, the Executive Director has submitted a proposed budget to the Board of Trustees on October 13, 2023, for its consideration, and;

**WHEREAS**, upon due and proper notice, published in accordance with the law, said proposed budget was open for inspection by the public at a designated place, as well as being posted on the PCCLD web site, a public hearing was held on November 16, 2023, and interested taxpayers were given the opportunity to file or register any objections to the proposed budget, and;

**WHEREAS**, whatever increases may have been made in the expenditures, like increases were added to the revenues so that the budget remains in balance, as required by law.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES FOR THE PUEBLO CITY-COUNTY LIBRARY DISTRICT:**

Section 1. That the budget as submitted, amended, and summarized by fund, hereby is approved and adopted as the budget of the Pueblo City-County Library District for the year stated above.

Section 2. That the budget hereby approved and adopted shall be signed by the President and Secretary of the Board of Trustees and made a part of the public records of the Pueblo City-County Library District.

**PUEBLO CITY-COUNTY LIBRARY DISTRICT  
RESOLUTION TO SET MILL LEVY**

A resolution levying general property taxes for the year 2023, to help defray the costs of providing library services to the Pueblo City-County Library District for the 2024 budget year.

**WHEREAS**, the Board of Trustees of the Pueblo City-County Library District has adopted the annual budget in accordance with the Local Government Budget Law on December 14, 2023, and;

**WHEREAS**, the amount of money necessary to balance the budget for general operating purposes is \$14,910,595, and;

**WHEREAS**, the 2023 net assessed valuation for the Pueblo City-County Library District as certified by the County Assessor on November 30, 2023 is \$2,247,365,346.

**NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE  
PUEBLO CITY-COUNTY LIBRARY DISTRICT:**

Section 1. That for the purpose of meeting all general operating expenses of the Pueblo City-County Library District during the 2024 budget year, there is hereby levied a tax of 6.6347 mills upon each dollar of the total valuation for assessment of all taxable property within Pueblo County for the year 2023.

Section 2. That the Chief Financial Officer is hereby authorized and directed to immediately certify to the County Commissioners of Pueblo County, Colorado, the mill levy for the Pueblo City-County Library District as determined above.
