**PREPARE TO MEET THEM**

Guatemala, Aug. 28.—The authorities have made preparations to repel and chastise any Mexican bandits who may seek to ravage the frontier territory of Guatemala. The report of an incursion having been reported in dispatches from Mexico. There is uneasiness in the Guatemalan inhabited frontier towns but outside apprehension is felt.
