Pueblo City-County Library District (PCCLD)

Studio 1315 at Pueblo City-County Library District (PCCLD) is a professional audio recording space where patrons can record music, podcasts, voiceovers, and other audio projects.

If a patron is under 18 years old (“Minor User”), a parent or legal guardian must complete and sign this form before the minor may use the studio.

Important

Using Studio 1315 is voluntary. The studio includes professional audio equipment, electrical components, and recording technology. While staff provide guidance, risks are still present.

By signing this form, you:

- Give permission for your child to use Studio 1315
- Accept the risks involved
- Agree not to hold PCCLD responsible for injuries or losses related to studio use

3. Studio Rules and Responsibilities

By signing below, I agree that:

- My child is capable of safely using recording equipment with staff guidance.
 - My child will follow all PCCLD policies and Studio 1315 guidelines.
 - My child will handle microphones, cables, headphones, and other equipment carefully.
 - I am financially responsible for any damage, loss, or required cleanup caused by my child.

4. Understanding the Risks

Studio 1315 may include:

- Microphones and stands
- Headphones and cables
- Audio mixers and recording software
- Musical instruments
- Electrical equipment and outlets

Possible risks include:

- Tripping over cables
- Equipment tipping or falling
- Electrical hazards
- Hearing strain from improper headphone use
- Injury caused by misuse of equipment

Although staff provide instruction and supervision, accidents may happen. Serious injury is unlikely but possible.

By signing this Agreement, I understand and accept these risks on behalf of my child.

5. Release of Liability

In exchange for allowing my child to use Studio 1315, I agree:

- Not to hold Pueblo City-County Library District (PCCLD), its Board of Trustees, employees, volunteers, or partners responsible for injuries, damages, or losses related to studio participation.

- To cover medical expenses or other costs resulting from my child's participation.

This release is intended to be as broad as allowed under Colorado law (C.R.S. § 13-22-107).

6. Medical Authorization

If my child becomes ill or injured while using Studio 1315, I authorize PCCLD staff to seek emergency medical treatment if necessary.

I understand that I am responsible for any associated medical costs.

7. Copyright Responsibility

PCCLD does not own content created in Studio 1315.

My child agrees not to violate copyright laws while recording or producing content. Any legal responsibility for copyright infringement belongs solely to the creator.

8. Acknowledgment and Signature

I have read and understand this Agreement. I voluntarily allow my child to participate in Studio 1315 activities and accept the terms above.
