RESOLUTION NO. 17-002

**THE BOARD OF COUNTY COMMISSIONERS
OF PUEBLO COUNTY, COLORADO**

**RATIFYING THE REAPPOINTMENT OF MEMBERS TO THE BOARD OF
TRUSTEES OF THE PUEBLO CITY-COUNTY LIBRARY DISTRICT**

WHEREAS, members of the Board of Trustees of the Pueblo City-County Library District are appointed by the City Council of the City of Pueblo ("City Council") and the Board of County Commissioners of Pueblo County, Colorado ("Board of County Commissioners"); and

WHEREAS, by Resolution No. 03-126, dated May 13, 2003, the Board of County Commissioners adopted policies and procedures for appointment of new members to the Board of Trustees of the City-County Library District, pursuant to the provisions of C.R.S. § 24-90-108(2)(e); and

WHEREAS, the aforementioned statute requires that trustee appointments be ratified by each legislative body participating in a library district; and

WHEREAS, by Resolution No. 11-267, dated December 20, 2011, the Board of County Commissioners of Pueblo County, Colorado, ratified the appointments of James H. Stuart and Frederick Quintana to the Pueblo City-County Library District Board of Trustees for terms expiring on December 31, 2016; and

WHEREAS, Public Notice soliciting applications from persons interested in serving on the Board of Trustees of the Pueblo City-County Library District to fill two (2) vacancies were published in *The Pueblo Chieftain* on October 16, 2016, on both the City of Pueblo and Pueblo County webpages, and two (2) applications were received in response to said Public Notice; and

WHEREAS, pursuant to C.R.S. § 24-90-108(2)(c), the nominating committee has reviewed the applications, and recommends to ratify the reappointment of James H. Stuart and Frederick Quintana to the Board of Trustees of the Pueblo City-County Library District, for terms expiring on December 31, 2021; and


WHEREAS, the Pueblo City Council and the Board of County Commissioners of Pueblo County, Colorado, jointly concur with said recommendation, and now this Board desires to ratify said appointments.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Pueblo County, Colorado, that the reappointment of James H. Stuart and Frederick Quintana to the Board of Trustees of the Pueblo City-County Library District for terms commencing on January 1, 2017, and expiring on December 31, 2021, are hereby ratified and approved, and that the Staff to the Board is hereby authorized and directed to notify the aforementioned members of their appointments by providing them, the Pueblo City Clerk, and the Pueblo City-County Library District with a copy of this Resolution.
