LOBBYIST'S REPORT [Jerry Braden, Amber Valdez, Ruben Valdez] Legislative Session Wrap-up Budget

- The Long Bill was approved. It included the \$2.5 million for publicly funded libraries. It is expected that the Governor will signas soon as the review is completed.
- The bill requiring school districts to split funds more equally with charter schools was a big compromise during the session. Its passage was likely due to House Speaker Crisanta Duran's ability to communicate with the Unions.
- Of all of the bills passed this year, SB17-267, Sustainability of Rural Colorado, will provide the biggest fiscal help to
 the state. This bill should provide some relief from TABOR as it moves Hospital Provider Fees into an enterprise fund,
 it allows use of Certificates of Participation (CoPs), and allocates 10% of the fund to transit. \$30 million will go to
 schools.
- Small businesss credit from marijuana funds were approved.
 One of the challenges of this bill is that all State departments will be expected to submit a 2% decrease to their budgets. The cut is not mandatory so the legislature may choose to not enforce the cuts.
- Senate Republicans killed a lot of bills that had monies attached so there might be some dollars available for distribution.

Colorado House Resolution to US Congress and Legislator of the Year Award

The House Resolution in support of libraries introduced by Representative Leslie Herod (District 8) was approved by a unanimous vote. Jerry and Ruben followed-up with Senator Angela Williams who concurred that it was appropriate to not pursue the resolution with the Senate.

For her interest in supporting libraries through an effort to encourage the US Congress to continue grant funding, the Legislative Committee has identified Representative Herod as the 2017 Legislator of the Year.

As Denver Public Library is in Representative Herod's district; Robin Filipczak, who is both a DPL staff member and chair of the CAL Awards Committee will take lead on writing a paragraph for the CALCON Awards program as well as coordinate an event at a DPL location. There was brief speculation whether the local event could be held on October 6, 2017 – the day the Legislative Committee is meeting and before CALCON.

General Information

- Ruben shared that this was one of the best legislative sessions ever seen for Colorado. The final agreement on the SB17-267, even with the number of additional items were added to it, was a good bill to pass. It will provide relief in several areas.
- As of the May 12th meeting, there was a question as to whether the Governor would call for a Special Session. The Senate President warned that nothing will happen so that the action would be a waste of money. On May 19th, it was announced there would NOT be a special session.
- The 2018 elections will be next year's priority for legislators. It is likely what is happening in Washington D.C. will impact state politics. Some of the races to track include:

- If Representative Ed Perlmutter runs for Governor, there will be a race to fill his seat in the US Congress.
- Senator Beth Martinez Humenik (Dist 24) might have a fight to retain her seat.
- Senator Lucía Guzmán (Dist 34) is term-limited.
- o Representative Dan Pabon (District 4) is term-limited.

Proposed Action to Bring to CAL Board

Mike Johnston, former Colorado State Senator and candidate for Governor spoke at the 2017 Inter-Library Loan Conference. His responses to questions posed by attendees, indicated that he lacked knowledge about library funding, services, and operations. As he is one of many candidates that will be running for office in 2018, it seems appropriate for CAL to help inform the incoming legislative body on libraries as well as learn about their thoughts and concerns.

After some discussion, the Legislative Committee decided to recommend that the CAL Board approve developing an information sheet and asking the CAL Board to identify a Task Force to take this action. Upon recommendations from our Lobbyists, if this action is taken, the resulting document and possible in-person conversations will occur after the primaries (likely July 2018).

- Members of the Legislative Committee were alerted to a potential trend of comments that impact libraries. During a
 congressional hearing, a person from Arapahoe County spoke against library funding and noted that library boards
 should be elected.
 - This year also had a parent from Cherry Creek School District request that EBSCO be banned from schools While both requests did not impact legislation, this is a trend to monitor and possibly address.
- Jon Caldara, President of the Independence Institute, might pursue a lawsuit against the State for the Lease to Purchase program.

NATIONAL LEGISLATION

Lobby Day Follow-up

John Wilkinson, serving as our State Coordinator, worked with a team that included Deborah Deal, Julia Hill-Nichols, Eugene Hainer, Michelle Jeske, Kim Johnson, Diane Lapierre, Sasha Miller, and Carol Satersmoen to visit legislative offices in Washington DC.

Gene reported that people they talked to sounded very supportive. In general, there seemed to support in appropriations that the cuts would not go through for the various social services being mentioned. Senator Gardner was singled-out for his sponsorship of bill with a senator from Michigan to work on data transparency issues.

Keep contacting Senators – they are appropriating an additional \$1 million to IMLS. That will add dollars to Colorado this year. ALA is strongly encouraging a big push to have Senators sign the "Dear Appropriator" letter for IAL and LSTA. This is especially critical as President Trump's \$56 billion savings program targets library and education funds.

Other priority issues on the Library radar included revisions to copyright; loss of federal funding to other programs such as ESSA, NEA, and NSF; and requests that the FCC change rules on Net Neutrality and eRate.

Status of IMLS \$\$:

The full House has approved library funding at FY17 levels. By a 29-2 vote, the Senate appropriations committee approved full funding also, plus a \$4M increase for Grants to States (i.e. LSTA). That recommendation now goes to the full Senate for a vote later this month. This Library Journal article has more detail about the process



and what happens next. A big thank you to everyone who made calls since the news in March about library funding being eliminated.


