Background




Background

The Rawlings Library is one of two selective Federal Depository Libraries in Pueblo, CO. A number of years ago, the government documents collection was managed by a designated Documents Librarian. However, when this librarian assumed other duties, the collection was briefly coordinated by a Library Assistant, before entering a phase of inactivity. In October, 2010, Amy Nelson began processing the backlog of documents that had accumulated, as well as weeding the collection. It quickly became evident that the Rawlings Library lacks the space and staffing needed to effectively manage a tangible government publications collection. Additionally, a large percentage of federal documents have become available online in recent years and many depositories have embraced digital technology as an effective way to improve public access to government information. Therefore, in March of 2011, a Documents Committee was formed to examine options for migration to a digital depository. The Committee identified Marcive's Documents Without Shelves Service as a viable option to gain

Background

The Rawlings Library is one of two selective Federal Depository Libraries in Pueblo, CO. A number of years ago, the government documents collection was managed by a designated Documents Librarian. However, when this librarian assumed other duties, the collection was briefly coordinated by a Library Assistant, before entering a phase of inactivity. In October, 2010, Amy Nelson began processing the backlog of documents that had accumulated, as well as weeding the collection. It quickly became evident that the Rawlings Library lacks the space and staffing needed to effectively manage a tangible government publications collection. Additionally, a large percentage of federal documents have become available online in recent years and many depositories have embraced digital technology as an effective way to improve public access to government information. Therefore, In March of 2011, a Documents Committee was formed to examine options for migration to a digital depository. The Committee identified Marcive's Documents Without Shelves Service as a viable option to gain access to digital government publications. In June, 2011, the Committee met with depository staff from CSU-Pueblo to learn more about their experience with this service, where we discovered that CSU-Pueblo has a more robust tangible and digital collection, as well as greater resources to dedicate to federal documents management. We also learned that unlike PCCLD, CSU-Pueblo is not a state publications depository. Our Committee and representatives from the CSU-Pueblo Library staff therefore discussed the possibility of creating a collaborative Government Documents model in which PCCLD manages a state publications collection, and CSU-Pueblo manages a federal documents collection. A follow-up meeting between the PCCLD Executive Director and the CSU-Pueblo Library Dean resulted in an agreement to pursue a collaborative model for documents services. The Documents Committee therefore recommends that the Rawlings Library terminate its status as a Federal Depository and allocate its resources to the management of state publications instead.

Purpose

The Documents Committee has prepared this plan to assist library staff with the federal depository termination process and to strategically guide library staff activities during the transition to a State Publications Depository.

Recommendations

1. Create an action plan for management of PCCLD's government publications collection

3. Terminate status as a Federal Depository Library

- Withdraw and create offer lists for all federal publications in PCCLD's collection and work with Colorado Regional Librarian to dispose of remaining FDLP materials (Amy Nelson)

4. Improve management of current tangible state publication collection

- Determine the location where state publications will be shelved (Theia Bravo, Carol Rooney, Charlene Simms, Maria Tucker)
- Pull publications that have been interfiled in Reference, Nonfiction and Special Collections and re-shelve in one location (Theia Bravo)
- Update spreadsheet of state publications currently in PCCLD's collection (Theia Bravo)

5. Integrate records for state publications into library catalog

Target Date: March 1, 2012

- Configure ILS to appropriately download, filter and display state publication records (Technical Services)
- Catalog tangible items currently in PCCLD's collection (Technical Services)
- Download MARC Records for all 2010-2011 state publications from the Colorado State
 Library to include both tangible and digital items (Technical Services)
- Continue downloading new MARC records for state publications as they are released (Technical Services)

6. Increase staff knowledge and competencies related to retrieving Government Information

Target Date: March 1, 2012

Action items:

- Provide update at October 2011 Staff Training Day (Amy Nelson)
- Create 'Government Information' webpage (Amy Nelson and Maida Scott)
- Provide training at departmental staff meetings (Amy Nelson)

7. Increase public awareness of PCCLD's State Publications Depository and the collaborative agreement with CSU-Pueblo

- Create a brochure about PCCLD's state publications collection, webpage, and collaborative relationship with CSU-Pueblo (Community Relations)

- Each 7,500 square feet in size
- Books and other library materials
- Public-use computers, iPads, eReaders, laptops and wireless
- Public space for study and learning
- Community meeting space for people to gather to exchange ideas

WHY? THE NEED HAS BEEN IDENTIFIED

- 2009 and 2005 studies
 - Focus groups
 - Community surveys
 - o Demographic analysis
 - State and national standards
 - o Long-range financial planning
- A number of conclusions that have acted to guide PCCLD direction in last several years, resulting in:
 - o Record high use of libraries
 - New programs such as Teen program, expanded Children's program, Adult Literacy program, Hispanic Resource Center, Business & Vocation Center, Nonprofit Resource Center, and more.
 - Expansion of Pueblo West Library from 5,000 square feet in size to 28,000 square feet in size.
- Additional conclusion identifying underserved areas of the county:
 - Eastside poverty rate
 - Eastside median household income \$24,591 compared to \$34,029 for the City of Pueblo
 - Almost 1 in 3 (31.5%) on the Eastside live in poverty, compared with county-wide poverty rate of 16.9%
 - o Geographic separation of Greenhorn Valley and St. Charles Mesa

- Sites being finalized now on Pueblo's Eastside, the Greenhorn Valley and on St. Charles Mesa
- Goal is design in 2012, break ground on construction in 2013, and open for business in 2014
