Pueblo City-County Library District is honored with its recent selection as a Four Star Library.\* This recognition places our library district in the top echelon from among more than 7,000 libraries in the United States.

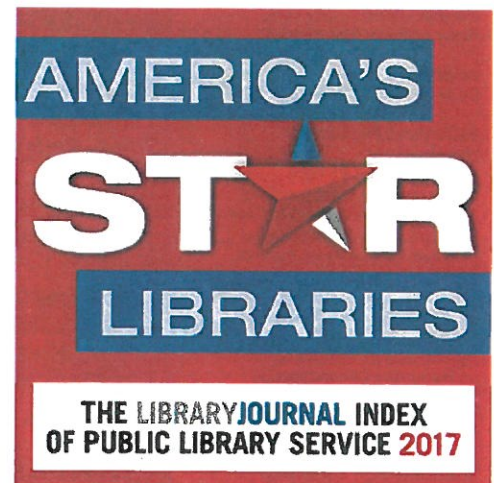
The beginning of the public library here dates from 1891, but the most recent years at the PCCLD are remarkable. Our results are so noteworthy that this could well be a golden age for public libraries here: beginning in 2003 with the completion of the signature Rawlings Library through 2009 with the expansion and renovation of the Pueblo West Library and continuing through the recent construction and opening of four additional new public libraries. PCCLD today consists of eight full-service outlets plus a host of outreach programs provided ongoing throughout the entire community.

We have seen a dramatic increase in commitment to local public libraries as measured by overall utilization. More people are visiting our libraries to use more books and other resources than ever before. During a period when the area population increased by

a modest 8.5 percent, PCCLD library program attendance grew seven-fold, annual circulation and library visits both more than doubled, and use of digital library resources skyrocketed.

Without the community's support, PCCLD would be hard-pressed to provide quality resources, spaces, and services in this fast-changing, dynamic world. We concentrate on six areas of strategic focus, founded on the thoughts and sentiments of the community we serve: 1. improving early literacy by creating young readers is a priority for the library; 2. partnering with other institutions to ensure PCCLD's continuing relevance to local citizens; 3. focusing on the whole family at all stages of life through specific library programming and collections; 4. bridging the digital divide by promoting access to the Internet and providing the best current information technology; 5. planning for the use of our limited resources based on concrete data to maximize community impact; 6. ensuring support for PCCLD staff, who are crucial to the successful fulfillment of our mission.

These themes serve as the framework for PCCLD's many accomplishments. Not only have we built several new libraries in recent years, but we also demonstrate institutional transparency such as with regular GFOA-certified financial reports, ensure our future financial needs via establishment of the Pueblo Library Foundation, and collaborate with the Friends of the Library to recently triple



membership and raise millions of dollars for our local libraries. We enhance service delivery with mobile staff technologies, maker programming, and special efforts to digitize historically-significant local documents. PCCLD's achievements include establishing the annual Booklovers Blacktie Ball fundraising event featuring personal appearances by noted authors of national notoriety, All Pueblo Reads cultural event series that attracted over 40,000 participants in 2017, an endowed program supporting personal local appearances by nationally-prominent children's authors, teen centers at all libraries helping significantly increase use of young adult materials and

In accordance with C.R.S. § 31-12-501(1):

Not more than thirty (30) days after receiving the notice required by subsection (1) of this section, either the Board of County Commissioners or the board of directors of any affected special district may request a meeting with the owner and the governing body of the municipality, or its appointee, to discuss and address any negative impacts on the county that would result from the disconnection. If such meeting is requested, the owner and the governing body or its appointee shall meet with either the Board of County Commissioners, or its appointee, or the board of any affected special district, or its appointee, not more than thirty days after the meeting was requested. Failure by either the Board of County Commissioners or the board of any affected special district to request a meeting constitutes an acknowledgment by the particular board that the disconnection will not adversely affect the county or an affected special district, as applicable.

**SUBJECT:** AN ORDINANCE DISCONNECTING PROPERTY FROM THE CITY OF PUEBLO COMMONLY KNOWN AS THE PUEBLO SPRINGS RANCH "LARIAT", GENERALLY DESCRIBED AS 362.802 ACRES OF LAND EAST OF INTERSTATE 25, SOUTH OF THE PUEBLO/EL PASO COUNTY LINE, AND NORTH OF COLORADO STATE UNIVERSITY-PUEBLO AND PUEBLO MEMORIAL AIRPORT PREVIOUSLY ANNEXED BY THE CITY ON JANUARY 28, 2008 BY ORDINANCE NOS. 7732 THROUGH 7738

### **SUMMARY:**

Attached for consideration is an Ordinance approving the disconnection of the Pueblo Springs Ranch "Lariat" property owned by the City of Pueblo containing 362.802 acres from the corporate limits of the City.

### **PREVIOUS COUNCIL ACTION:**

City Council approved the acceptance of a Warranty Deed and Right of Reversion dated October 22, 2007 between the City of Pueblo and Pueblo Springs Ranch, LLC for the 362.802 acres of property commonly known as the Pueblo Springs Ranch "Lariat" ("Property"). The Property was annexed into the City on January 28, 2008 as a series annexation by Ordinance Nos. 7732 through 7738.

### **BACKGROUND:**

Subject to the terms of the Warranty Deed and Right of Reversion dated October 22, 2007 between the City of Pueblo is disconnecting the Property from the corporate limits of the City in accordance with the requirements of the Colorado Revised Statutes. Following the disconnection of the Property, and the approval of an agreement between



the City and the three owners of the balance of the Pueblo Springs Ranch property, the City will convey the Lariat Property back to the property owners.

**FINANCIAL IMPLICATIONS:**

The City will no longer have any financial commitments for the Property after it is transferred back to the Pueblo Springs Ranch property owners.

**BOARD/COMMISSION RECOMMENDATION:**

Not applicable.

**STAKEHOLDER PROCESS:**

Not applicable.

**ALTERNATIVES:**

If City Council does not approve this Ordinance, the subject property would remain within corporate limits of the City, and will not comply with the Right of Reversion in the Warranty Deed dated October 22, 2007.

AN ORDINANCE DISCONNECTING PROPERTY FROM THE CITY OF PUEBLO COMMONLY KNOWN AS THE PUEBLO SPRINGS RANCH "LARIAT", GENERALLY DESCRIBED AS 362.802 ACRES OF LAND EAST OF INTERSTATE 25, SOUTH OF THE PUEBLO/EL PASO COUNTY LINE, AND NORTH OF COLORADO STATE UNIVERSITY-PUEBLO AND PUEBLO MEMORIAL AIRPORT PREVIOUSLY ANNEXED BY THE CITY ON JANUARY 28, 2008 BY ORDINANCE NOS. 7732 THROUGH 7738

WHEREAS, on October 22, 2007 City Council approved Resolution No. 13671 accepting a Warranty Deed and Right of Reversion between the City of Pueblo and Pueblo Springs Ranch, LLC, a Nevada Limited Liability Company. Said deed was recorded on November 8, 2008 at Reception No. 1748310 of the records of the Pueblo County Clerk and Recorder; and

WHEREAS, said deed conveyed to the City a "Lariat" of approximately 362.802 acres of land surrounding the proposed Pueblo Springs Ranch development ("Property"); and

WHEREAS, on January 28, 2008, by Ordinance Nos. 7732 through 7738, the Pueblo City Council annexed the approximately 362.802 acres of City-owned land comprising the "Lariat" in a series of seven (7) annexation phases; and

WHEREAS, Section 3 of said deed provided for a "triggering event" requiring the City to re-convey the "Lariat", and disconnect said Property from the corporate limits of the City of Pueblo if the Pueblo Springs Ranch property (internal to the "Lariat") was not annexed into the City of Pueblo by December 31, 2008; and

WHEREAS, by agreement of the parties, the date of the "triggering event" was extended six (6) times, as follows:

1. A fully executed Modification Agreement (No. 1) dated December 31, 2007 and recorded on January 23, 2008 at Reception No. 1755620 of the records of the Pueblo County Clerk and Recorder;
2. A fully executed Modification Agreement (No. 2) dated December 22, 2008 and recorded on January 14, 2009 at Reception No. 1792907 of the records of the Pueblo County Clerk and Recorder;
3. A fully executed Modification Agreement (No. 3) dated January 11, 2010 and recorded on February 17, 2010 at Reception No. 1833476 of the records of the Pueblo County Clerk and Recorder;



4. A fully executed Modification Agreement (No. 4) dated January 24, 2011, expiring January 31, 2013, and recorded on April 1, 2011 at Reception No. 1871515 of the records of the Pueblo County Clerk and Recorder; and
5. A fully executed Modification Agreement (No. 5) dated January 28, 2013, expiring January 31, 2014, and recorded on May 16, 2013 at Reception No. 1943231 of the records of the Pueblo County Clerk and Recorder; and
6. A fully executed Modification Agreement (No. 6) dated January 27, 2014, expiring January 31, 2017, and recorded on February 12, 2014 at Reception No. 1967421 of the records of the Pueblo County Clerk and Recorder; and

WHEREAS, the "triggering event" was not extended beyond the January 31, 2017 date established in the fully executed Modification Agreement dated January 27, 2014, thereby requiring the City to re-convey the "Lariat", and disconnect said Property from the corporate limits of the City of Pueblo; and

WHEREAS, pursuant to §31-12-501 C.R.S., the City Council has the authority to disconnect land within and adjacent to the corporate boundary of the City. NOW THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF PUEBLO, that:

#### SECTION 1.

The following described area situated within the City of Pueblo, Colorado, is hereby disconnected from the corporate limits of the City, and the official map of the City shall be amended to show such disconnection:

## SECTION 2.

The foregoing recitals are incorporated herein and made a part of this Ordinance.

## SECTION 3.

The City Council hereby finds and determines that the City owns the area to be disconnected.

## SECTION 4.

Ordinances No. 7732, 7733, 7734, 7735, 7736, 7737, and 7738 are hereby rescinded.

## SECTION 5.

Within thirty (30) days after the effective date of the Ordinance, the City Clerk shall:

(a) File one copy of the disconnection maps with the original of this ordinance in the office of the City Clerk;

(b) File for recording three certified copies of this Ordinance and disconnection map with the Pueblo County Clerk and Recorder;

(c) File one certified copy of the disconnection map and this Ordinance with the Southeastern Colorado Water Conservancy District.

## SECTION 6.

The officers and staff of the City are authorized and directed to perform any and all acts consistent with the intent of the Ordinance to effectuate the policies and procedures described herein.

SECTION 7.

This Ordinance shall become effective immediately upon final passage.
