#### Xcel utility plan crucial to EVRAZ, Pueblo jobs

The future of EVRAZ Pueblo as a major local employer hinges on Colorado Public Utilities

Commission approval of Xcel's energy plan for serving all of its electric utility customers -- of which

EVRAZ is the largest in the state.

A pending EVRAZ-Xcel power rate pact aimed at keeping the steelmaker and its 1,000-employee workforce in Pueblo also depends on PUC regulatory approval. The commissioners — Chairman Jeff Ackermann and members Frances Koncilja and Wendy Moser — are expected to vote on the Xcel plan early next month. The PUC has been expecting Xcel and EVRAZ to reach some agreement — which augurs good news for Pueblo.

Hanging in the balance is a much-anticipated EVRAZ expansion of the Pueblo plant, estimated at \$500 million. Pueblo economic development officials are cautiously optimistic that approval of the Xcel power plan, coupled with a competitive incentive package, will mean the difference in EVRAZ staying here instead of moving to another state.

Potentially, EVRAZ upgrades and expansion could mean more jobs for Pueblo.

Part of Xcel's plan is to decommission two of the three Comanche coal-fired units and replace the electricity with solar, wind and natural gas power sources. In fact, a key feature is Xcel's plan to build one of its planned new solar farms -- a 240-megawatt power source -- on EVRAZ property.

Xcel officials expressed confidence the jobs lost at Comanche 1 and 2 would be more than offset by the growth in the renewable energy field.

"We saw a great opportunity to retain a valued customer, assist in its expansion in one of Southern Colorado's premier communities and increase use of cleaner energy," Alice Jackson, Xcel's Colorado president, said in a statement last week.

Xcel rates are crucial, as Conrad Winkler, president and chief executive officer for EVRAZ North America, said: "Achieving long-term price certainty on energy is a key first ingredient for considering further investments."

The steel plant has a long business relationship with Xcel. They were once known widely as Public Service Co. of Colorado (now Xcel) and CF&I Steel Corp. (now EVRAZ).

It can continue to be a mutually beneficial relationship even though Xcel serves no other customers in Pueblo except EVRAZ.

As it sits now, the PUC's decision on Xcel regulatory filings shapes up as a potential all-or-nothing case for a thousand or more jobs in Pueblo. There's a lot at stake.
